**MISS MARTIN COUNTY FAIR SCHOLARSHIP PAGEANT
RULES & REGULATIONS**

****ALL CONTESTANTS MUST SUBMIT AN ENTRY FEE OF \$35.00****

(This can be a Sponsorship from a business, organization, association or individual)

1. Contest is open to all females in the 9th, 10th or 11th grades of the Martin County School District.
2. Contestants must have been a resident of Martin County for the 12 months preceding the opening of the Fair.
3. The Pageant shall be limited to the first 40 female entries.
4. Contestants must be single and never have been married.
5. Past Queens of the Martin County Fair cannot participate.
6. Contestants shall not be related to any of the members of the Miss Martin County Fair Committee or any of the Judges.
7. Preliminary judging, Thursday night, will be based on charm, graciousness, personality and poise. Final judging, Friday night, will be based on stage presence, confidence, response to emcee and delivery.
8. There will be no swim suit or talent competition.
9. Contestants will be required to wear evening gowns on Friday, February 10, 2012 for the contest.
10. The Queen shall portray good morals, manners and conduct. She should conduct herself with dignity at all times and be a credit to the Martin County Fair Association.
11. Failure to follow these rules will be considered cause for dismissal.
12. Decision of the judges will be final and all scores will be kept confidential.
13. \$500 Scholarship from the Martin County Fair Association to the Fair Queen.
14. The Miss Martin County Fair Committee will hold a luncheon on Saturday January 28, 2012, at 11:30 am, in Building A, Martin County Fairgrounds. All contestants must attend.
15. Mandatory Dance Rehearsal, February 6 - 9, 2012. (subject to change). From 6-9pm.
16. The contestant whose name is signed below gives permission to the Miss Martin County Fair Pageant and its Sponsors, to use her photograph, speeches, video, etc., for publicity purposes and future pageant material. They become the property of the pageant.
17. The Queen and all members of the Queen's Court are required to be a part of all activities during the Fair, and as needed during the year.

The duties of the selected Miss Martin County Fair shall include, but not be limited to the following:

- *Officiate evenings during Fair Week*
- *Represent the Martin County Fair Association (as Miss Martin County Fair) at various community and civic events throughout the year when invited to participate.*
